#### **Meeting Biz:**

Second Appeal Letter regarding houselessness - Lynn

Do we (as an association) want to send out another letter to the city regarding our houseless neighbors? Have more campers coming in and

trash building up.

The louder our voices are and the more people who speak up the more likely it is that we will have a solution. Would love to send an appeal to the neighbors to send an email to the Mayor, Sam Adams, and the new crisis coordination group.

Lynn to drive putting together the email and Jessy to format/edit it.

Shomps - Rapid Response has been down to remove some of the trash in the areas that you are mentioning. COR is trying to put together a community clean up event, we are looking at the Columbia Slough as a possible location. Shomps to get us more information as the event comes together. Shomps will check with the owner of Rapid Response to see what the plan is and what/where the city is targeting for clean up.

The city has put out new garbage cans at various locations for trash. There is build up of trash along the road near designated trash bins. The city does have a team that they send out to pick up trash around those new cans. Shomps to send us the name of this clean up team so that we can reach out when we see build up of trash.

### Storage Unit - Bill

Mark and Bill moved the signs out of storage and are no longer using the unit. Bill has the signs on his deck but they need to be moved. Bill is trying to find a new storage unit but can be stored at his house for now (but not for the long term). EPCO does have storage units but they are all full right now.

We will check back in on this in a couple of months.

# Flags at busy crosswalks - Mark and Lynn

Mark has reached out to PBOT for free flags. Mark has also sent out an email showing a See-Me Flag (it's a kit) that costs \$90 but has everything in it for flags at crossings.

We do want to check on the liability issues with this.

Lynn motions to go to a vote to move ahead with the flags for 60 days. Bill to second the motion. 5 are aye, 4 are nay.

We are not moving forward with the flags.

Jessy is going to move forward with pushing the city for speed signs and speed vans.
